**Regolamenti ta' l-2006 li jemendaw ir-Regolamenti dwar
il-Liċenzi tal-Pulizija (Emenda Nru. 2)**

BIS-SAHHA tas-setghat moghtija lilu bl-artikolu 3 ta' l-Att dwar il-Liċenzi tal-Pulizija, il-Viċi Prim Ministru u Ministru tal-Ġustizzja u l-Intern, bi qbil mal-Prim Ministru u Ministru tal-Finanzi, għamel dawn ir-regolamenti li ġejjin:–

1. **POLICE LICENCES ACT
(CAP. 128)**

Police Licences (Amendment) (No. 2) Regulations, 2006

IN exercise of the powers conferred by article 3 of the Police Licences Act, the Deputy Prime Minister and Minister of Justice and Home Affairs, with the concurrence of the Prime Minister and Minister of Finance, has made the following regulations:-

1. (1) The title of these regulations is the Police Licences (Amendment) (No. 2) Regulations, 2006, and they shall be read and construed as one with the Police Licences Regulations, 1949, hereinafter referred to as “the principal regulations”. Citation and coming into force.

(2) These regulations shall come into force on the 15th August, 2006.

2. In the First Schedule to the principal regulations, for items 2 to 8 thereof there shall be substituted the following new items 2 to 8B:- Amends First Schedule to the principal regulations.

“2. For the purchase of any firearm which requires a licence and to keep such firearm during the year of its purchase	7.00
3. To keep a firearm or firearms during any year following the year of purchase thereof, per annum	7.00
4. To deal in arms, ammunition, arms proper or to keep or to expose for sale or to repair arms, per annum	50.00
5. (1) To act as a substitute or as an apprentice in dealing of arms, ammunition, arms proper or in repairing such arms, per annum.....	25.00
(2) To act as a range officer during the practice of target shooting	5.00
6. To keep a harpoon during any year following the year of purchase thereof, per annum	3.00

7. To carry a harpoon, arcbow or crossbow, or a firearm for sporting purposes (not being hunting), per annum	1.50
8. (a) To carry a firearm for hunting purposes on land (excluding hunting for wild rabbit), per annum	12.00
(b) To carry a firearm for hunting purposes from on board any seacraft three kilometres from the coast, per annum	30.00
(c) To carry firearms for the purpose of hunting wild rabbit, per annum	5.00
8A. (1) To keep a place (<i>shooting ranges</i>) where target shooting activities with licenced firearms are held, per annum	50.00
(2) To hold target shooting activities with air weapons in mobile shooting galleries, for each day	30.00
(3) To hold clay pigeon shooting in places which are not licenced as <i>shooting range</i> , for each day	3.00
8B. To keep a firearm collection:	
(1) for the first 50 arms	7.00
(2) from 51 to 150 arms	20.00
(3) from 151 and more	30.00".
